Call to Action #1

Oppose House bill reducing access to abortion to 20 weeks.

Write or Email: Senators Harris and Feinstein

Wade, invades the doctor-patient relationship, and **restricts women's liberty**. I want you to publicly oppose this legislation as it moves to the Senate and stand up for women everywhere. Call to Action #2

Advocate for common sense gun protections.

Call to Action #3:

Advocate for ICE oversight and humane treatment of detainees.

Write: Dana or Mimi

Script: *Dear [name], I would like you to support accountability and transparency in the ICE detention system. In taxpayer-funded immigration detention centers around the US, [in-depth reports show](#) that ICE imprisons asylum-seekers and treats people inhumanely (providing inadequate food, insufficient medical care, and subjecting people to solitary confinement). Reps. Adam Smith and **Pramila Jayapal's** Dignity for Detained Immigrants Act, addresses these wrongs. I would like you to co-sponsor this legislation. Thank you. Name, address*
