### Call to Action #1

Advocate for the ability to vote by mail nationally to prevent some forms of voter suppression.

Call: Senators Feinstein and Harris and your US Representative

Script: *Hi. I'm calling from [ZIP] to advocate for all Americans being able to vote by mail. [Four states already do this](#) and enjoy increased voter participation, decreased costs, greater convenience, and [better security](#). I would like [name] to support the Vote by Mail Act ([S. 1231/H.R. 2669](#)). Have they already co-sponsored this legislation? (If not, will they?) Thank you.*

### Call to Action #2

Advocate for a clean Dream Act. Even if you already have before.

Call: Senators Feinstein and Harris and your US Representative

Script: *Hi. I'm from [ZIP] and am calling to ask [name] to support the [Dream Act](#) without funding [a border wall](#) or increased enforcement. The president must not use human lives as leverage for his racism. Thank you.*

### Call to Action #3

Limit Russian influence. Advocate for transparency in political ads.

Call: Senators Feinstein and Harris and your US Representative

Script: *Hi. I'm from [ZIP] calling to ask [name] to support [the Honest Ads Act](#). Americans deserve to know who is paying for political ads, and this bipartisan effort improves transparency in online advertising. I would like [name] to cosponsor [S. 1989/H.R. 4077](#) while still in committee. Thank you.*
